You will be paid for training. A 2-hour training session is required for all election judges. Head judge positions require 4 hours of training. Training session information will be sent to you at a later date.

1. I am eligible to vote in the State of Minnesota.
2. I am able to read, write and speak English.
3. I am not a candidate on the ballot.
4. I am not the spouse, parent, child, stepchild, sibling, stepbrother or stepsister of a candidate on the ballot.
5. I am not permanently or temporarily domiciled with any candidate on the ballot.
6. I am not serving as a challenger in the State Primary or General Election.

Furthermore, I certify that I will remain courteous and professional; refrain from partisan comments or discussions; avoid any action that may influence how a person votes; and respect the privacy of voters.
